Ray Powell, New Mexico State Land Commissioner, will be the featured speaker at the Sept. 8 Luncheon Unit meeting. It will be held at 11:45 a.m. at the MCM Elegante Hotel, 2020 Menaul NE. Commissioner Ray Powell

Powell is a veterinarian who received his Doctorate of Veterinary Medicine from Tufts University with an emphasis in wildlife medicine in 1985. Prior to his election as Commissioner of Public Lands in 2010, Powell worked with world-renowned scientist and humanitarian Dr. Jane Goodall and the Jane Goodall Institute to foster relationships with youth to make the world a better place and to empower youth to make a positive difference.

Powell is a native of Albuquerque and attended Albuquerque Public Schools. He received his bachelor's degree in anthropology and biology and a master's degree in botany and plant ecology from the University of New Mexico. He served as Commissioner of Public Lands from 1993-2002

and was president and vice president of the 22-member Western States Land Commission Association.

The LWVNM Natural Resources Committee is launching a fresh examination of land use which will culminate in a draft policy for members to consider in 2012 or 2013.

Other September speakers will include:

* Evening Unit, Sept. 13, 6 p.m., Towers Apartment community room, 5404 Montgomery -- Several board members of the Middle Rio Grande Conservancy District will discuss the current challenges and future outlook for the MRGCD.

* Midtown Unit, Sept. 19, 1:30 p.m., Manzano del Sol Hobby Room -- Albuquerque Senior Planner Carol Toffaleti will educate us on the city's growth and development plans and future forecast for land use planning in this area.

* Northeast Heights Unit, Sept. 26, 10 a.m., La Vida Llena Card Room, 10501 Lagrima de Oro NE -- LWVNM Natural Resources Director Lora Lucero will provide an historic timeline of state land use laws which impact local decision-making.

Presidents' Corner

Mark your calendar for Sunday, Oct. 16. The LWVC-NM is co-sponsoring a program devoted to global warming and climate change with the New Mexico Chapter of the Fulbright Association and Sigma Xi National Scientific Research Society. The news media this summer has brought public attention to local, state, national and worldwide global warming and its effects. Thankfully, our Los Alamos League members were able to return to their homes without loss. I returned this week from three weeks in Kenya and Tanzania and was keenly aware of how the people in Africa are suffering from the drought. The animals are suffering from lack of water, and the Maasai people have lost most of their herds, which are their livelihood. Refugees from drought-ridden Somalia are also greatly suffering.

The LWVCNM Board is pleased to be asked to team up with the Fulbright Foundation on Perspectives on Climate Change. The event will be held at the Jewish Community Center, 5520 Wyoming Blvd. in Albuquerque on Sunday, Oct. 16 at 3 p.m. The Fulbright Association is the alumni arm of the U.S. State Department's Fulbright program, where members are all former Fulbright Scholars. Over 100 members of the New Mexico Chapter represent dozens of host countries where members are taught to conduct research. One of the association's goals is to foster dialogue on global issues, and the global issue of the New Mexico Chapter is to examine climate change. This event will be more of a tutorial than a debate, but discussion will be educational and encouraged.

The program is as follows:

Introduction: "Current views in Congress on the threats of global warming," Senator Jeff Bingaman (by video)

Panel: "The scientific evidence that growing carbon dioxide levels and global warming are largely of human origin"

Panelists include:

* Professor David Gutzler of UNM who will talk about "Predicted climate changes caused by global warming and their likely consequences"

* Dr. Mark Boslough of Sandia National Laboratories who will talk about "Obstacles standing in the way of addressing global warming- a business community"

* Jeff Sterba, CEO (retired) PNM

Q & A, moderated by John Fleck, science writer for the *Albuquerque Journal*

The event is open to the public. Please invite your friends and acquaintances to attend, as the event will be very informative.

Voter Services Fall Round-up

Voter Registration--Training is available at one brief session for how to register voters. If you have already been trained, you are "set to go." Just remember your number, and if you forget, the County Clerk's office can help you. Of course you are welcome to take the training as a refresher. Registration is an important service that the League provides, and you can work on this at your own pace and schedule.

Voter Protection is another service you can provide. This involves being an observer at the polls on Election Day. You note whether the polling place opens/closes at the promised time and you pay attention to how voters are treated, reporting any irregularities you observe. Common Cause provides training and places you in an observer team with others. The

polls are open 7 a.m. to 7 p.m., and if you can't work a full day, you can be scheduled to a team with shifts. Again, contact Gayle Prinkey (see above). Training sessions will take place late in September.

How to apply for absentee ballot -- The deadline is Sept. 30. 1) Go to City Clerk's office in ABQ-Bernalillo City-County Hall; 2) Email request to absenteeapplication@cabq.gov; 3) Call 311 and that service will submit your request to City Clerk. This is the easiest way, and you will be given a confirmation number.

Absentee ballots will be mailed starting Aug. 30. They may be mailed or taken to clerk's office or voting site by the voter or immediate family member. They must be received by 7 p.m. on election day.

LWVNM receives \$5,000 grant

LWVNM has received a \$5,000 grant for public advocacy for voter protection from the LWVUS. The focus will be on the Santa Fe and Central New Mexico areas.

The scope of work will include: opposing voter photo ID wherever it arises -- whether in the upcoming special session of the Legislature, in the regular session or in Rio Rancho should the ballot initiative on photo ID pass in their upcoming municipal elections.

Advocacy also includes increasing compliance with the National Voter Registration Act; protecting voter rights, particularly in underserved communities, and improving polling management by monitoring and training election observers for the Albuquerque municipal election on Oct 4.

This is LWVNM's second grant on the PAVP project, and there may be more funding next year, 2012, a very busy election year.
