Rules for Annual Meeting

1. No person may speak twice to the same motion until all who wish to speak have had an opportunity to do so.
2. Each speaker is limited to two minutes.
3. All motions must be made in writing and a copy given to the Secretary.
4. Only members in good standing will be allowed to speak on a motion.

Local Positions

Drug Policy

LWVCNM supports drug court programs; treatment for all persons with drug addiction; and syringe exchange programs in Bernalillo County. These programs should be prudently and appropriately funded.

LWVCNM supports pain management for all persons through:

Cooperation among consumers, health care professionals and regulatory agencies to promote pain relief and to decrease abuse, trafficking, and diversion of pain medications;

Education of consumers including: awareness that pain can be treated; the variety of therapies available and how to describe to health care professionals the levels and types of pain they are suffering;

Training of health care professionals and providers including: awareness that pain can be treated; how to identify and treat pain; and when to refer for specialized treatment; and

Research on more effective pain treatments and therapies and widespread dissemination of research results.

LWVCNM believes pain management is the process of providing care to alleviate or reduce acute and chronic pain, which can also cause secondary disease processes (e.g., high blood pressure). This care may include pain medications and a variety of therapies proven by research to be effective. (2002, Rev. 2003, 2007, 2008)

Education

Support of a requirement that functional competence in basic skills be demonstrated before a high school diploma is awarded.

Emphasis on basic skills that should include the fine arts (including music, art, and drama), STEM subjects (science, technology, engineering and mathematics) and ongoing technological developments. Identification of children at risk should begin early in the educational process and continue through high school. Remediation should be provided as early as possible.

An alternative path to a high school diploma should be available.

Support for community colleges that should offer certificates and associate degrees for a variety of careers. Such degrees could be terminal or transferable toward a four-year program.

Support for the protection of the First Amendment rights of public school students and library patrons.

Support for a selection policy for school and public libraries that allows for access to a wide variety of materials.

Support for a purchase and distribution system of instructional materials for public schools that is timely and cost effective.

Support for the selection of basic instructional materials for the public schools by a committee which consists of administrators, teachers, and parents and that represents a cross section of the ethnic, geographic and economic population of the community.

In addition, resource persons who have expertise in the subject under consideration will serve in an advisory capacity.

Support for a selection procedure that includes:

- a. A fair and thorough evaluation of materials;
- b. A method for public examination and input;
- c. A strong conflict of interest policy.

Support for a policy that allows for informal resolution of controversy and a systematic reconsideration procedure for textbook and library materials. (rev. 2009)

Health Care

LWVCNM supports comprehensive health care, mental health care, preventive and educational health programs, comprehensive reproductive health care, including abortion, and home health care.

LWVCNM believes society has a responsibility to provide comprehensive health care for the indigent and supports mill levies as a means of funding such health care. (rev. 2009)

Housing

Local government has primary responsibility for making available, facilitating, and coordinating provision of affordable, decent, and safe housing using federal, state, county, or city funds. This may also be done by coordination with private builders, non-profit organizations, and/or foundations.

We support the following guidelines for government assisted housing:

- a. Assistance for private affordable housing projects under the following conditions:
 1. The surrounding neighborhood has been involved early in the planning for the project; and
 2. Regulatory variances which may be granted do not permit unsafe or unsightly conditions.
- b. Design review by a qualified panel.
- c. A variety of home ownership and rental opportunities in public or private affordable housing projects
- d. An adequate maintenance system in all affordable housing projects. This system should include education and training for residents in maintenance skills.
- e. Encouragement of the formation of tenant organizations.
- f. Long Range planning, accountability, and neighborhood involvement in expenditure of federal Community Development Block Grant funds for housing rehabilitation.
- g. Leadership in assistance for homeless programs which provide both shelter and services for targeted populations, particularly families and the mentally ill.
- h. Boarding houses as a way of meeting housing needs.
- i. Community-based residential care for the mentally ill. (rev. 2009)

Initiative and Referendum

The LWVCNM supports the Initiative & Referendum process. However, we have reached a

consensus on the need for revision of four specific sections of the Albuquerque City Charter. We support the appointment of a Charter Revision Committee to study the process for qualifying Initiative and Referenda, with a view to revising Article III, Section 3 of the Albuquerque City Charter that would:

- a. Increase the number of initiators needed to start the process;
- b. Increase the number of signatures required to compel an election;
- c. Refine the process of reviewing the petition title and summary; and
- d. Eliminate the requirement that the election must be held within 90 days after the date of filing the petition with appropriate signatures. (rev. 2009)

Local Government

Support for the development of budgets that provide for long-range planning and evaluation programs.

Support for municipal and county officials providing the media and citizens' groups with simplified budget information. This should occur prior to public hearings as a means of preparing citizens for the budget process.

Support for assessing the cost and effectiveness of programs supported by federal funds.

Support for local governments to share in the New Mexico personal income tax as the most effective and equitable source of revenue.

Support of combined form of government for Albuquerque and Bernalillo County.

Support for coordinating village, city, and county government with joint use of records.

Support for nonpartisan local government elections.

Support for:

- a. The present Mayor/Council form of government for Albuquerque;
- b. A significant increase in the number of signatures

required on a petition before a person can be placed on the ballot as a candidate for mayor for Albuquerque. Preferably, the number of signatures should be based on either percentage of voters having voted in the last mayoral election or of Registered voters, or of population of the city. (rev. 2009)

Land Use

Land use decisions must be made with consideration for economic, environmental and social factors. We believe that it is possible to incorporate the principles of conservation of resources, to relate the use of land to its inherent characteristics and carrying capacities and still achieve an optimum balance between economic and social needs and environmental quality.

Support of development that protects natural resources and promotes the equal right of all to an environment beneficial to life.

Support of land use policies and techniques that promote orderly growth. These shall include:

- a. Urban infill, to include residential building in downtown and midcity areas;
- b. Acquisition and appropriate use of open space;

- c. Preservation of agricultural lands as such;
- d. Utilization of mixed use in new development and in redevelopment;
- e. Revitalization of blighted sections of the community;
- f. Composition of neighborhoods to include a diversity of types of housing and of socioeconomic groups.

Support for coordinated city/ county and regional planning and zoning.

Support for coordinated regional land use and transportation planning. (rev. 2009)

Transportation

Support for coordinated regional land use and transportation planning. This planning shall include:

- a. Consideration of the impact of traffic congestion;
- b. The provision of viable transportation choices.

Support for a regional public transit system with a policy-making board that includes citizens with voting powers. (rev. 2009)

Water

Support for coordinated regional water planning.

Bylaws Committee Report

The 2014 Bylaws Committee recommends the following change to the LWVCNM Bylaws:

ARTICLE VIII, Nomination and Election.

Section 3, Election. ~~The election shall be by ballot, provided that when there is but one nominee for each office, the Secretary shall be instructed to cast the ballot for every nominee.~~ A majority vote of those qualified to vote and voting shall constitute an election. Absentee or proxy voting shall not be permitted.

Robert's Rules of Order does not provide for a secretary casting a ballot for nominees. However, an organization's bylaws take precedence over *Roberts' Rules*. Because elections at LWVCNM consist of voice vote or acclamation, we recommend removal of this clause. It would not preclude future contested elections from being handled by secret ballot.

Annual Meeting Reports

Presidents' Report

The year has been extremely busy and very fruitful. Right after last year's meeting, our League took part in a panel discussion about opportunities in which organizations can assist newly elected women to office. This was during the initial annual seminar called "Ready to Run" which was conducted at UNM.

This year, we initiated the Membership and Leadership Development Program, which LWVUS developed to assist local leagues recruit new members. You may hear us refer to it as MLD. We are striving to be much more focused on our exposure to the general public and particularly pointed in asking them to join our organization at every opportunity. This is an area that every single one of us can do.

We had timekeeper training as part of Voter Services for anyone interested in working with our forums. There were numerous occasions in which we registered eligible voters -- sometimes at farmers' markets, neighborhood rallies, La Vida Llena, schools, and hospital picnics. We also conducted registration agent training for anyone, non-members included. As part of our Voter Services, we helped to usher in new American citizens at Naturalization ceremonies. These newly-sworn United States citizens were given a voter registration form and made aware they were now eligible to apply to vote in elections.

Central New Mexico is taking part in a new state study on Behavioral Health Care Services and enlisted committee members from the other leagues in the state. It is on-going and always accepting new members. You can contribute any time. It's a fantastic educational tool for us all.

We conducted three candidate forums this year, one for the City Council District 7 here in Albuquerque, one for the Village of Corrales, and one for the Democratic Party's gubernatorial race. This league assisted KNME TV in their Mayoral Forum by enlisting the help of our members to for-

mulate questions to be asked of the candidates. We also assisted KOAT TV in their Mayoral Forum with our excellent timekeeping for the event.

Technology Report

This year, a Contribution Page was added to the LWVCNM.ORG website, which allows people to contribute to either the Operations Fund or the Education Fund via Paypal. The secure Paypal interface allows for contributions via any credit card or Paypal account. The page went up, barely in time for Ed Fund contributions to support the *Voters' Guide* and collected about \$1,330 from members and the public.

Contributions to the Operations Fund are always rare, but a new Membership page ("Join Us!") was added so that new members and renewing members could pay their dues online (to the Operations Fund) via Paypal. Again, this feature was phased in late, but so far, 18 members have signed up using it. As an added experiment, the page was used to sell 4 tickets to the 2014 Theater Party.

The other major technology platform, the LWVCNM Topics mailing list, has continued its usefulness. There are currently 203 members on the list, and messages are posted to the list daily. Members are reminded that there are two additional lists they can join, which are maintained by the State League: LWVNM Topics and LWVNM Action. LWVNM Topics covers issues of statewide interest. Voter Services

The League provided moderator and time-keeper services for several candidate forums over the past year.

On Aug. 29 the Coalition of Neighborhood Associations, District 7 sponsored a candidate forum for the office of city council in District 7. It was held at the Sheraton Uptown. Steve Wentworth was moderator, and Cheryl Haaker was timekeeper. KOAT-TV, Channel 7 sponsored a mayoral forum on Sept. 22 in cooperation with the League of Women Voters of Central New Mexico. Cheryl Haaker provided the timekeeping.

There was also a mayoral forum sponsored by KNME in conjunction with the League. It aired on Sept. 30. Gene Grant of KNME was moderator, and Gayle Prinkey was timekeeper.

The Village of Corrales sponsored a candidate forum on Feb. 6 in anticipation of the Corrales election of March 4. The offices for the forum were city councilors in Districts 1, 3 and 4 and mayor. Diane Goldfarb moderated the forum, and Gayle Prinkey did timekeeping. The forum was very well attended and was a big success.

The Bernalillo County Democratic Party sponsored a gubernatorial candidate forum for the candidates running for Democratic Party ticket for governor. The forum took place at Carpenter's Hall on Wednesday March 5. Steve Wentworth was moderator and Gayle Prinkey was timekeeper. The hall was packed and new questions for the five candidates kept coming in throughout the forum.

Megan Brown of League VOTE 411 posted information for all the candidate forums.

On Saturday, Aug. 24 Anne Arrasmith and Veronica Cordova from the County Clerk's Office provided the League with voter registration training. The total number of League voter registrars is now 20. Voter registrars from the League registered voters at a number of events throughout the year. Among them were the South West Alliance and Neighborhood annual event, the Equal Rights Amendment Celebration in Tiquex Park, a Wherry Elementary School event, a UNM Hospitals employee picnic and Senator Candelaria's New Mexico's 26th District First Annual Job Fair. May Program: State of the New Mexico Economy and Why

Lee Reynis, director of the Bureau of Business and Economic Research at the University of New Mexico, will be the guest speaker at the May 3 Annual Meeting.

We hear a lot about the New Mexico economy, usually by people pushing a particular agenda. Lee Reynis will give us the actual data on what is really happening and some of the explanations for why it is happening. Is New Mexico's economic recovery slower than the rest of the country, and if so, why? Are we losing people and jobs? If so, what types of people, skills, and jobs and how is it affecting our economy? How critical are taxes to economic development and jobs and where does

New Mexico rank? These are critical questions and it's important to get the real data from an unbiased source not pushing specific policies.

Lee Reynis became director of the BBER in 1999. Prior to that she was the City Economist for Albuquerque and Chief Economist for the New Mexico Department of Finance and Administration. She is involved in producing the quarterly economic forecast for New Mexico and for Albuquerque, Santa Fe, and Las Cruces. Some of her research has included studies of the Santa Fe living wage, the management and future of federal investment in New Mexico and several studies of New Mexico health care. She has a PhD in economics from the University of Michigan.
